To whom it may concern,

I am writing to you today to notify you that we are launching a consultation on our school's admissions arrangements. We are proud of our Admissions Policy and, as such, have made no changes to the arrangements outlined within it. We want to ensure, however, that the arrangements continue to be suitable and fair for those in our community, and we seek your views and any concerns you may have about the arrangements as they stand. In line with the 'School admissions code', this consultation will run for six weeks, from 20 December 2022 to 31 January 2023.

As mentioned, we have not made any changes to our admissions arrangements as we feel they are still open, fair and reflective of the current situation in our local area. We are consulting in line with the statutory obligation that a consultation is carried out on the school admissions arrangements at least once every seven years.

After the close of the consultation, the admissions authority will meet to consider responses. The outcome of the consultation will be published on the school website as soon as possible once we have reached a decision, and the final admissions arrangements will follow shortly after.
