# Information for professionals, parents and carers

who have concerns about a young person's online sexual behaviour

If a young person's online sexual behaviour has raised concerns about sexual harm to them or others, what can you do?

### What's the problem?

At the Lucy Faithfull Foundation we know that young people are increasingly getting into trouble online. We often receive calls on our free, confidential Stop it Now! Helpline (0808 1000 900) from worried parents. The worries parents most commonly call us about include:

- their child has been looking at adult pornography
- their child has been sending or receiving sexually explicit pictures
- their child has been arrested for viewing indecent images of under 18s.

For most parents, discovering that their child has been engaging in inappropriate sexual behaviour online is initially shocking, and quickly followed by fears for their child's welfare and confusion about what to do.

The behaviour may have resulted in sexual harm to the young person themselves or to other children or young people, and it could be illegal; sometimes it is all three. Whether the discovery was made by you, or was brought to your attention by a school, the police or another professional, it is likely you will have some urgent questions about how you can help your child and what might happen next. Knowing who you can talk to is the first step to getting the right help and support. We want to give you that help and support.

# **Information for professionals, parents and carers** who have concerns about a young person's online sexual behaviour

### What is the Inform Young People's Programme?

The Inform Young People's programme is a voluntary programme designed for young people who have got into trouble online.

We offer one initial meeting followed by up to five sessions of work with the young person and their family tailored to their needs. Each session is delivered by an experienced practitioner either by telephone (through our Helpline) or face-to-face.

Content is tailored to address issues around a young person putting him/herself at risk, as well as potentially causing harm to others. The work aims to:

- Provide information, advice and support to the young person and their parents or carers
- Alleviate the young person's (and parents'/carers') distress and anxiety arising from their concerning sexual behaviour coming to light
- Give practical advice on strategies to prevent a re-occurrence or escalation of the concerning sexual behaviour including aids to responsible use of technology
- Give sound information about the law in this context, especially as it applies to young people
- Facilitate more open communication between the young person and their parents or carers

### What will the service cost?

The Foundation is able to deliver the Inform Young People's Programme free of charge if certain criteria are met. We also welcome donations to support the costs of delivery. Please call us to discuss.

### Other services for young people

In the event that the young person requires more indepth intervention and/or safeguarding procedures need to be implemented, this will be discussed with you. The Foundation can provide additional assessment, intervention and consultancy services provided funding is available.

They will help you explore options, including managing future behaviour. This service is available to anyone with concerns about potentially abusive situations, whether that be online or offline.
